WE ARE NATIONALLY AND INTERNATIONALLY RECOGNIZED FOR OUR CAREFULLY CURATED EXHIBITIONS, WHICH FEATURE SIGNIFICANT HISTORICAL MATERIAL AS WELL AS INSIGHTFUL AND RELEVANT CONTEMPORARY PHOTOGRAPHY. DURING THE 2021 FISCAL YEAR, FMOPA PRESENTED OVER 20 EXHIBITIONS FEATURING SEMINAL WORK BY EMERGING AND ESTABLISHED PHOTOGRAPHERS WHO ARE BOTH LOCAL TO THE TAMPA BAY COMMUNITY AS WELL AS INTERNATIONALLY RECOGNIZED. THESE EXHIBITIONS HELPED SHAPE AND INFORM THE CULTURAL LANDSCAPE OF THE GREATER TAMPA BAY AREA AND ADVANCED THE MUSEUM'S ROLE AS A CENTER OF ARTS EDUCATION.

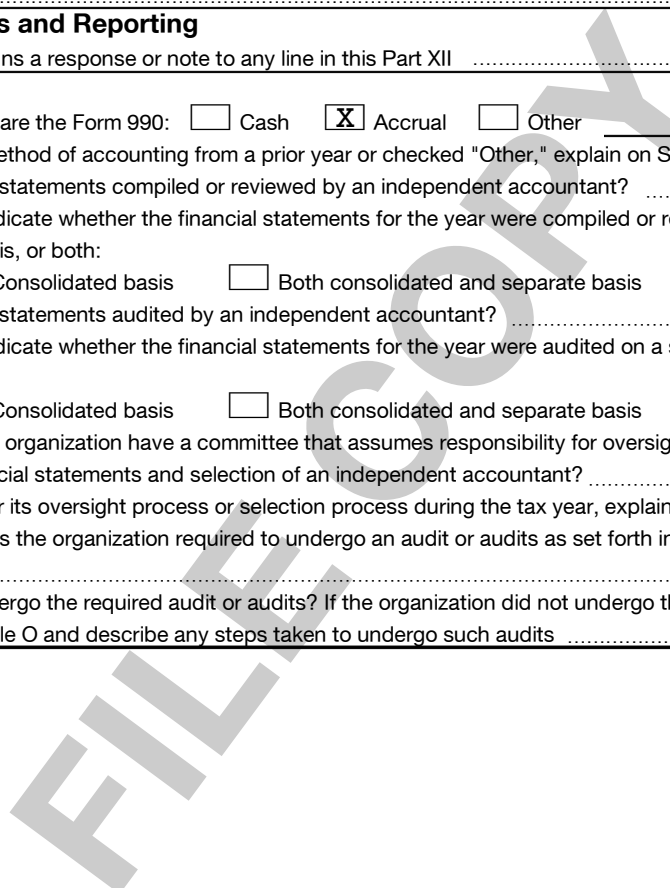

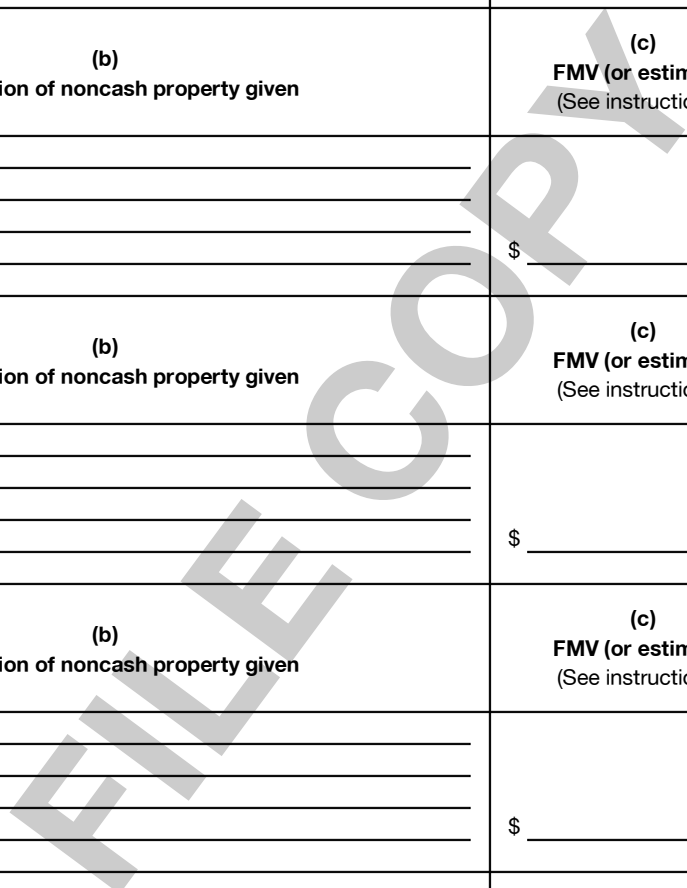
